### **1. Information We Collect**

We may collect the following information:

Full name, address, and contact information

Government-issued ID (where required)

Billing and payment information

Package content description (as required by customs)

Tracking, delivery, and pickup records

Communication with our staff (calls, emails, messages)

### **2. Purpose of Data Collection**

Your information is used strictly for:

- Shipping, delivery, and tracking of packages
- Customs clearance and legal compliance
- Customer service and support
- Internal record-keeping
- Payment processing
- Fraud prevention and risk assessment
- Service improvement and analysis

### **3. Sharing of Information**

We may share your information with:

Customs and regulatory bodies (to comply with Jamaican laws)

Third-party logistics providers or agents involved in package handling

Payment processors to complete transactions

Law enforcement if legally required

We do not sell or rent your data to third parties for marketing or advertising.

#### **4. Data Retention**

We retain customer data for up to 7 years, or as required by Jamaican law for auditing and customs compliance. After this period, your data is securely deleted.\

#### **5. Customer Rights**

You have the right to:

Request access to the personal data we hold about you

Request corrections to inaccurate data

Request deletion (where applicable and not in breach of law)

Withdraw consent to use your data (where consent was required)

We take reasonable measures to protect your information from unauthorized access, loss, or misuse, including:
