

PRIVACY TERMS AND AGREEMENT

- o Usage data (pages visited, clicks, etc.) and cookies
- Location data (if enabled)



2. How We Use Your Information

We use the collected information for the following purposes:

- **Service Provision**: To process your shipments, manage orders, and provide tracking and delivery updates.
- **Billing and Payment Processing**: To handle payment transactions and invoicing for services rendered.
- **Communication**: To send transactional messages (e.g., order confirmations, shipment updates) and promotional content (if opted-in).
- **Improving Services**: To enhance the functionality, security, and overall user experience of our Platform.
- **Legal Compliance**: To fulfill our obligations under applicable law, including customs, tax, and regulatory requirements.

3. How We Protect Your Information

We take reasonable and appropriate measures to safeguard your personal information from unauthorized access, alteration, disclosure, or destruction. These measures include encryption, secure servers, and access controls.
